### Father De Celles' Respect Life Homily of October 2nd:

#### **Other Significant Respect Life Articles and Activities this Past Month:**

1. Our friend, Mike Taylor, the Executive Director of the National Committee for the Human Life Amendment (a lobbying arm of the bishop's conference) sent to us an important legislative alert to support the Labor/Health and Human Services appropriation bill (not yet numbered) containing the Abortion Non-Discrimination Act (ANDA). It is critical that this conscience protection bill remains as part of this legislation. **Please take action immediately by going to the [NCHLA website](#) and sending a letter to our representative and senators.**

ANDA strengthens existing federal conscience protection laws and affirms the principle that no health care entity should be forced by government to perform or participate in abortions.

The need for ANDA is clear from recent increased threats against pro-life health care providers. The U.S. Department of Health and Human Services has begun discriminating against grant applicants that will not do abortion referrals, claiming that current conscience laws forbid this form of discrimination. The University of Medicine and Dentistry of New Jersey recently threatened the jobs of twelve nurses who would not assist in abortions, saying the nurses have no right to sue them in court because existing conscience laws do not clearly permit such lawsuits. In California, state officials are demanding that even Catholic organizations provide abortion coverage, arguing that current federal laws permitting organizations to not pay for coverage that they are morally opposed to do not apply. Furthermore it stated that the federal government would never deny California all its Medicaid and Medicare funds as a penalty for infractions as currently mandated under the Labor/HHS bill. These threats will only grow unless ANDA is enacted now.

2. We are pleased that Marjorie Dannenfelser, President of Susan B. Anthony (SBA) List, will speak in our parish hall on February 9<sup>th</sup> as the third presenter for the St. Raymond's 2011-2012 Speaker Program. Susan B. Anthony List carries out part of the mandate in [Faithful Citizenship](#) by identifying and supporting political candidates who believe that "The direct and intentional destruction of innocent human life from the moment of conception until natural death is always wrong and not just one issue among many." (#28). The Susan B. Anthony List, and its connected Political Action Committee, the SBA List Candidate Fund, are dedicated to electing candidates and pursuing policies that will reduce and ultimately end abortion. To that end, the SBA List will emphasize the election, education, promotion, and mobilization of pro-life women. 3. The Secretary of Health and Human Services (HHS) has rejected a Food and Drug Administration (FDA) decision to provide over the counter Plan B (morning after pill) to all women without a prescription. She limited the over the counter sale of the pill to only those women who were over the age of 17. We, as Catholics, should be outraged that the Pill is available for anyone, especially over the counter. Plan B can be an abortifacient if taken around the time of fertilization (woman's egg meets man's sperm). It also has shown to have many side effects – similar to the side effects that the FDA also reported this week about the more recently approved birth control pill. This is another slippery slope issue that Catholics and others have been following for years. It all began at the beginning of the Obama Administration when he announced that Plan B would be provided over the counter for women 18 and older. While there was much said about it at the time, nothing could be done because it was a unilateral presidential ruling. Now, the FDA was ready to make it available to anyone – including 15 year olds – without a prescription and without parent consent. Stay tuned, actions have consequences. As with many of the birth control pills on the market, the side effects have been devastating to relationships, marriages, and the health of the woman. The birth control pill

makes a woman's reproductive system "sick" by altering a healthy major functioning part of her body.
